His first position at Aerojet, in 1992, was as Director of Business Development for its Tactical Electronic & Weapon Systems business. In all positions, Mr. Peoples continued to enhance his experience in the areas of strategic planning, market strategy, business development, executive management and international activities.

Mr. Peoples joined Aerojet from Raytheon where he was Manager of Business Development for Smart Munitions Programs. Prior to this, Mr. Peoples' career included appointment as Special Assistant to the Assistant Secretary of Defense for Acquisition; member of the Army staff; and extensive international assignments in the Middle East, Central America, Europe and Asia.

Mr. Peoples holds a BA in Business Administration from Benedictine College and an MS in International Relations from Troy State University. In addition, he is a graduate of the Defense Systems Management College Program Manager's course, and the Raytheon Advanced Management Program.
